


Hertfordshire and West Essex Shared Care Record Introduction for Health and Care Professionals

Working together for a healthier future

The Shared Care Record creates a read-only summary view of an individual's health and care record in one place



The technology used is called the **Health Information Exchange** or 'HIE', provided by Cerner.

A summary view shared by all users *Not the full patient record.*

Organisations will decide what to share and what can technically be shared.

Easy, instant access

The Shared Care Record is integrated within each organisation's own record system. No separate login or password.


Up to date information at point of care In most cases, data is relayed directly from the original record, rather than being saved or transferred.





Information is shown in sections (also called pods/widgets)


Some show lists of related items pulled from more than one place. Some sources, such as GP records, have their own section. The same type of information i.e. medications will therefore be found in more than one section.



These can be easily re-ordered by dragging and dropping and expanded or collapsed. This creates a personalised view of the Shared Care Record.

Information is shown in chronological order and can be sorted or filtered by date or source organisation.

Information is shared with partners in **nine** Integrated Care Systems outside of HWE (including the five ICSs that make up the London Care Record).



- Problems chronic/unresolved (displayed in HIE 'Problem List' with onset date)
- Diagnosis (displayed in HIE 'Problem List' without onset date)
- Procedures
- Pathology (lab results, cellular pathology, microbiology)
- Radiology reports
- Social history
- Vital signs

*NB: CUH appointments will display within the 'Care Plan' section of the HIE as a report titled 'Plan of care'. Please be aware there may be several entries as a report is generated each time an encounter is recorded for the individual.

Mental Health and Specialist Learning Disability Services (excluding IAPT).

NB: Information from HPFT does not appear in the 'Mental health' section of the HIE, it is distributed across relevant sections such as 'Referrals' and 'Problems'.

- Associated carer
- Disability
- Risk type
- Case details

NB: Adult social care active cases only

The Shared Care Record is read-only summary of selected data. The amount of information available will differ between organisations and increase over time. Data sets shared by all partners can be found on the ICS website here

The same type of information from different sources may be displayed in more than one place within Shared Care Record. For example, GP medications be in the 'GP Record' section, but medications issued by hospitals may be in the 'Medications' section.





In line with our existing *My Care Record* approach and UK GDPR, there is no need to ask for an individual's consent to share information for direct care.

We will use the *My Care Record* website and communication materials to maintain **transparency with the public** about how their information is being used.

Use of the Shared Care Record will be based on the **existing role-based access**. Full audit trail maintained.

The Shared Care Record is for **direct care only**. Users should inform individuals that they are accessing their records whenever possible.

Read-only access. No printing or taking screenshots to prevent duplication and out of date information being used.






